I. ROLL CALL

## II. ADOPTION OF AGENDA

## V. REPORTS (3-5 minutes each)

A. A.S. Executives

Amanda has nothing to report, Katrina announces her judicial meeting tomorrow and their agenda. Julietta discusses her activities from her committee meeting today 9/17- from STEM classes, parking, therapists on campus, etc. Brenda reports that she is looking for people to help with planning of the Cadena center events. Erik reports his standing committee tabled the budget discussion for AS room modifications. David encourages people to join his standing committee if you like making reels and such.

Samiy discusses his experience at the district board of trustees. The issue with protecting undocumented students was resolved.

  Cynthia met with the director of health services to discuss the lack of
  therapists on campus, there is no director of behavior health to review
  licensed therapists, which is why they have no therapists on campus. They
  are working on revising the mission statement, which got rejected.

# VI. NEW BUSINESS

- A. Student Senate will discuss the advantages and disadvantages of the Inter-Club Council (ICC) merging with AS.
  - Brenda motions to discuss this, Samiy seconded. Samiy shares his opinion and experience as a previous ICC rep for multiple clubs last semester. Julietta asks for the cons. Brenda shares her opinion as someone present and helping lead the last ICC meeting past Friday. Amanda discusses that some of the responsibilities that were previously the ICC's responsibilities might be delegated to AS, which could be an interesting shift. A few senators give their input, with most/all agreeing that they hope ICC will still be a separate entity. A senator suggests that VP of ICC has no vote on club issues at meetings.
- B. Student Senate will vote on approving the \$500 budget for the Cadena x Latinx Heritage Month event. Katrina motions to discuss, Samiy seconded. Samiy motioned to vote to approve the budget, a senator seconded. A unanimous vote passes.
- C. Student Senate will discuss concerns with safety and spot availability in the different campus parking areas.

  Brenda motioned to discuss this, Julietta seconded. Brenda shares her experience talking to campus safety, introducing herself as an exec, and them saying that the only way to make change is through the students. Idea of parking meters. Increased parking/traffic control. A senator suggests a second handicapped parking spot near the food bank.
- D. Student Senate will discuss experiences with STEM course grading policies at Fullerton College.
  - Amanda mentions the discussion of STEM grading policies at the RPR committee with Julietta earlier, and that this topic has be brought to light a lot lately. Erik mentions that many STEM professors at Fullerton College pride themselves on their classes being difficult and rigorous. Senate discusses possible solutions such as a policy where professors are required for a certain curve of students to pass tests and such. Brenda mentions that STEM professors might retaliate stating that the STEM department have this rule, but the other departments do not.
